General Instructions:

1. The registration will be done on 1st come 1st serve basis.
2. It has been decided by ICAI RVO to charge a nominal registration fees as most of the members register for the training and do not attend the same. This has happened in most of the online CEP trainings conducted by ICAI RVO.
3. The registration fee is non-refundable.
4. The CEP training details will be only hosted on ICAI RVO website. (As many members complain they don't receive mails from ICAI RVO or do not see the mails frequently, and by the time they respond the seats are already full)

7. As per IBBI Guidelines we can accommodate only 100 participants in one batch and the registrations will be closed after 100 participants.
