1. The registration will be done on 1st come 1st serve basis.
2. *If you have already attended CEP training for any of the above mentioned topics, kindly do not register yourself for repeated topic as the registration may not be allowed*

and the preference will be given to member who has not attended the session previously.

3. It has been decided by ICAI RVO to charge a nominal registration fees as most of the members register for the training and do not attend the same. This has happened in all the 8 online CEP trainings conducted by ICAI RVO.
- 4. The registration fee is non-refundable.**
5. The CEP training details will be only hosted on ICAI RVO website.(As many members complain they don't receive mails from ICAI RVO or do not see the mails frequently, and by the time they respond the seats are already full)
6. The details of the monthly CEP trainings will be hosted on ICAI RVO website between 1st to 10th of every month on a regular basis.
- 7. The video of the participant has to be compulsorily on during the entire training session as per directions of IBBI.**
